THE SHOW

Saturday and Sunday, November 5-6, 2011

The 40th Annual South Miami Art Festival is an annual JURIED fine arts show under the sponsorship of Chamber South. The location of the festival is along 72nd Avenue (Sunset Drive) in downtown South Miami, Florida. South Miami is centered within ten minutes of the highest per capita income communities in the Southeastern United States.

ELIGIBILITY/RULES FOR ENTRY

- A completed application
- Compact disk with images*
- A non-refundable jury fee for each application**
- A check for exhibit fee

*All digital images must be sent via email or compact disk. You must submit five images (four of your artwork and one of your booth display).

Images are requested to be 1920 x 1920 pixels at 72 dpi. Saved as high-resolution, baseline JPEG format.

The image file size must be less than 1.8MB.

Each image should be labeled with your name, category and numbered one through five. Example: Doe John Photography 1.JPG

Images should be RGB

If your image is not square, please mask it with black or white.

**2010 winners are invited to return exempt from jurying. These winners will be accepted upon receipt of their completed application and images prior to jury deadline.

CATEGORIES ACCEPTED

Clay & Glass, Fiber, Jewelry & Metalwork, Leather, Mixed Media, Painting, Photography, Printmaking/Drawing/Digital Art, Sculpture, Watercolor, Wood.

We do not accept any commercially produced work. Works made from commercially produced patterns, castings, items made from kits, embellished items or mass-produced items, regardless of enhancements will not be permitted.

REPRODUCTIONS "CAFÉ RULES"

Reproductions of an artist's one-of-a-kind original paintings, drawings, collage or mixed media may be exhibited subject to the following conditions:

- All reproductions must be signed and numbered.
- All reproductions whether framed or unframed, must be clearly and individually labeled "reproduction" or "limited edition".
- All unframed reproductions may be displayed in browse bins.
- Framed reproductions may be displayed or hung on one wall of the booth, not to exceed ten (10) linear feet.

In addition to cash and ribbons, all award recipients will be honored with non-juried invitations to next year's show.

The 40th Annual South Miami Art Festival, a fine art show featuring juried artists from across the country, returns to Sunset Drive between South Dixie Highway and Red Road. The event is free to the public, providing an outstanding cultural experience for residents and visitors. The festival kicks off the festival season in Miami-Dade County and provides a multi-cultural experience in a family setting. This year's South Miami Art Festival is on November 5-6. Considering our string of rankings in the top 100 fine arts shows in the country by Sunshine Artist Magazine, you won't want to miss this show!

Artists will be judged at the show and winners will be honored with \$8,000.00 in cash prizes.

FESTIVAL RULES

- Artist must be present in the booth for the length of the show, Saturday, November 5th and Sunday, November 6th. The show hours are 10:00 am - 6:00 pm.
- No booth sharing is permitted. Assistants and/or partners may accompany the artist, but commercial agents, representatives, dealers, hired sales people or relatives cannot replace the artist.
- WE DO NOT SUPPLY TENTS. Each artists is responsible for providing a display unit that is weighted and is suitable for outdoor use on a paved surface and able to withstand many types of weather conditions and crowds. Set up is on Saturday, November 5th at 6:30 am. No spikes, stakes, or nails may be driven into the asphalt.
- Exhibit spaces measure 10' by 10'. Double spaces are available. All artwork must be displayed inside the booth space. No seating is allowed in the pedestrian walkway. No generators allowed. The festival does not provide electricity.
- Each artist sells directly to the public and must individually comply and is responsible for collection of 7% Florida Sales Tax.

APPLICATION

A completed application is a contract to exhibit in the South Miami Art Festival. If an artist is invited to exhibit, absolutely no refunds will be made. You may withdraw your application prior to the jury date 9/1/2011. At this time the jury fee and booth fee will be returned. After 9/1/2011 there will be no refunds. Artists that have been accepted and are unable to attend should inform the Festival in writing of their

cancellation. Artists may enter in multiple categories for jurying but will be accepted in only one category, Artists working together may apply as one if they collaborate on every piece. If accepted, they may exhibit only pieces which are collaborations. Incomplete applications will not be processed. Enclose a self addressed stamped standard sized envelope. Applications must be postmarked no later than 7/31/2011.

FEES

Standard Space \$300.00, tax included.
Corner Space \$350.00, tax included.
Jury Fee \$25.00 per application/category.

Payments must be made in two separate checks. Partial refunds will be made if corner space is not available.

Your space is reserved when your check clears. Deposited checks returned by the bank will void entry into the show.

NOTIFICATION

The jury will review all five images by 9/1/2011. Applicants will be sent notification on their status by 9/15/2011. Exhibit fees will be returned to artists not accepted. Artists may be selected as alternates and will be placed on the waiting list. Exhibit fees will be held until you are called due to space availability by 10/15/2011. If you accept, your check will be deposited at that time.

FESTIVAL POSTER

Artists are invited to submit images and a biography if they would like to be considered for the festival's poster. If interested, please check the box at the bottom of the application.

All applications and payments MUST BE POSTMARKED BY 9/1/2011. No exceptions will be made.

Notification will be made via email only by 9/15/2011.
